## **Gift of Appreciated Securities Form**

A great way to make a gift to Boston Partners in Education (Boston Partners) is through the transfer of appreciated publicly traded securities held for over one year. Upon transfer, you are entitled to a federal income tax deduction for the market value of the securities. In addition, neither you nor Boston Partners is taxable on the long term gain realized upon the sale of the stock.

For example, if you bought stock ten years ago for \$1,000 and it is now worth \$10,000, you may give it to Boston Partners and be entitled to a \$10,000 federal income tax deduction. You also avoid any tax on the \$9,000 gain that would be taxable if you had sold the stock and then gave the proceeds to Boston Partners.

The value of the deduction is generally limited to 30% of your adjusted gross income in the year of the gift, but any excess deduction may be carried over and used over the next five years.

If the securities have been owned for less than one year, the charitable tax deduction is based on your cost in purchasing the security, but again neither you nor Boston Partners is taxable on the gain.
