Dear Friends:

Thank you for being part of our community. FY24 was a rebuilding year for Boston Partners in Education - after facing a tremendous fiscal gap in FY23 and filling it thanks to your generosity - we spent FY24 learning new ways to approach our work.

With the success of the Raise Your Hand Campaign, we were able to offer our programs uninterrupted at the start of the school year, fulfilling our obligations to our school partners and Boston Public Schools families. We matched academic mentors with over 1,200 BPS students, providing them with thousands of hours of academic and social-emotional support.

One of the most exciting changes was launching Pathfinders. Pathfinders is our reimagined version of Big Cheese Reads, our career exploration program. We were able to retain what people loved most about BCR, while improving the impact of the visits through greater teacher and student voice in the matching process.

We also leveraged the momentum of the Raise Your Hand campaign to reshape our fundraising strategies. The biggest change we made was shifting our annual gala to the fall, hosting our first gala since May of 2023 this past October. While it was a little nerve-wracking to have a fiscal year without our signature event, this was an important move for several reasons. First, it made space for the Pathfinders Open, our new spring golf tournament. We spent a beautiful day at Wentworth-bythe-Sea, and look forward to an even bigger and better event this year. The shift is also strategically important because it places the gala, which is a vital fundraising effort for the organization, at the beginning of our fiscal year, rather than the end. This helps us hit the ground running and ensures that our programs can launch smoothly to serve our students as quickly as possible.



Pathfinders Update

After over twenty years of creating unforgettable experiences, we have successfully rebranded our signature The Big Cheese Reads initiative into Pathfinders. The Big Cheese Reads was created by Boston Partners in Education (BPiE) to offer Boston Public Schools (BPS) students an opportunity to interact with local professionals in various fields. Visits would consist of a classroom read-aloud by said professional and followed by a career-focused discussion/question session. It was also a successful fundraising strategy for BPIE - program participation was connected to sponsorship of our annual gala. However, as time went on, we began to hear from teachers and students that the initiative was not resonating in the classroom as much as it had in the past.

Our participants - readers, teachers, and students alike - felt that the program reinforced an uncomfortable hierarchy - Big Cheeses imparting their wisdom to the classroom, rather than hearing what the students' interests and needs were. The question-and-answer portion of the initiative had always been the most powerful part of the experience for everyone, so we wanted to preserve that connection while making the program more responsive to the needs of the teachers and students. We phased out the reading and created a nomination form so that we could hear from teachers directly about the needs of their classrooms. They can let us know the sorts of speakers and career pathways the class is focused on, and when the visit fits into their schedules.

In the next school year, we will continue to diversify the types of people we bring into classrooms: speakers of all genders, races, backgrounds, and career paths. In doing so, we hope to inspire BPS students and open their eyes to the infinite possibilities their futures hold.



Rich and Jamal's Connection

Twenty-five years ago, Rich Greif contacted Boston Partners in Education, hoping to connect to the Boston community in which he worked by becoming a reading mentor. Rich was matched with Jamal Jones, a student at Blackstone Elementary School. What neither Rich nor Jamal could have guessed when they first met that fall of 1999 was the profound impact the experience would have on both of them, and the lasting bond they would form.

For three years, while Jamal was in the second through fourth grade, Rich would visit the Blackstone and read with Jamal for about an hour each week. While reflecting on this time spent together, Rich described Jamal as a natural "people person" and an overall fun kid. Jamal had a strong relationship with his mother and grandmother – and Rich stayed connected to Jamal's mother, ensuring that his support was an extension and reinforcement of hers – but Rich learned that Jamal did not have any prominent adult male figures in his life. When their formal mentormentee relationship came to an end, Rich and Jamal continued to stay in touch; Rich and his family even attended Jamal's graduation from East Boston High School. Celebrating milestones and sharing wins is a critical aspect of any good mentoring relationship.

After graduation, Jamal began attending the University of New Hampshire, an experience which introduced new academic and interpersonal challenges. Jamal's mother and Rich teamed up to ensure that Jamal would persevere through college. Together, they encouraged Jamal to reach out to professors and assisted him in accessing help through UNH's academic support program. Surrounded by this team, Jamal succeeded in his pursuit of a four-year degree. Once again, Rich was by his side for graduation. Being able to ask for and receive help is a critical skill for success.

Despite all of the years that have passed and the changes that have occurred in each of their lives, Rich and Jamal have never lost touch. Rich continues to be a guide and resource for Jamal, and Jamal supports Rich, too. They both joined us at our Boston Partners in Education Gala back in October, where they shared their story and highlighted the power of mentoring.

Whether a mentoring relationship lasts for one year or for twenty-five, the lessons in resilience, problem-solving, and community-building last a lifetime. Boston Partners in Education serves as the critical bridge between students who need extra support and community members who have volunteered as academic mentors.



Transparency Report

In FY22, we launched our first Transparency Report - a look at the demographic and geographic makeup of our volunteers, staff, and board, and how they compared to those of the Boston Public Schools students we serve. The purpose of this report was to understand how aligned - or not - our organization is with the lived experiences of our youth.

In FY24, we moved beyond demographics to reviewing our policies and practices in order to advance inclusion in all facets of our work. To the right are some of the highlights of our FY24 efforts:







HR Policies







We updated our HR policies, hiring materials, and processes to reflect more respectful identity-based language. We also included explicit questions about a commitment to diversity, equity, inclusion, and belonging (DEIB) to our interview process.

We updated our volunteer mentor application forms to more explicitly capture applicants' comfort and interest in working with specific student populations, including multilingual learners and students with disabilities, and updated the student nomination forms to capture more specific information about students' unique needs. We also added more questions about the accommodations that volunteers need to be successful in their matches.

We updated our training materials and website to include resources to help volunteers provide support requested by teachers, families, and students, including dedicated resource sections on social-emotional learning, academic support by subject, interactive virtual tools, and standardized test preparation materials, as well as resources for meeting basic needs like food, clothing, and shelter sites.

With BPS's Office of Data and Accountability, we aligned our internal demographic data labels with those of the Department of Elementary and Secondary Education (DESE) for clarity and accuracy. This provided more specific race and ethnicity categories for our volunteers to more meaningfully self-identify, while updating our race and ethnicity labels for students to align with BPS district standards, allowing us to compare our internal demographic data to that of the district.




